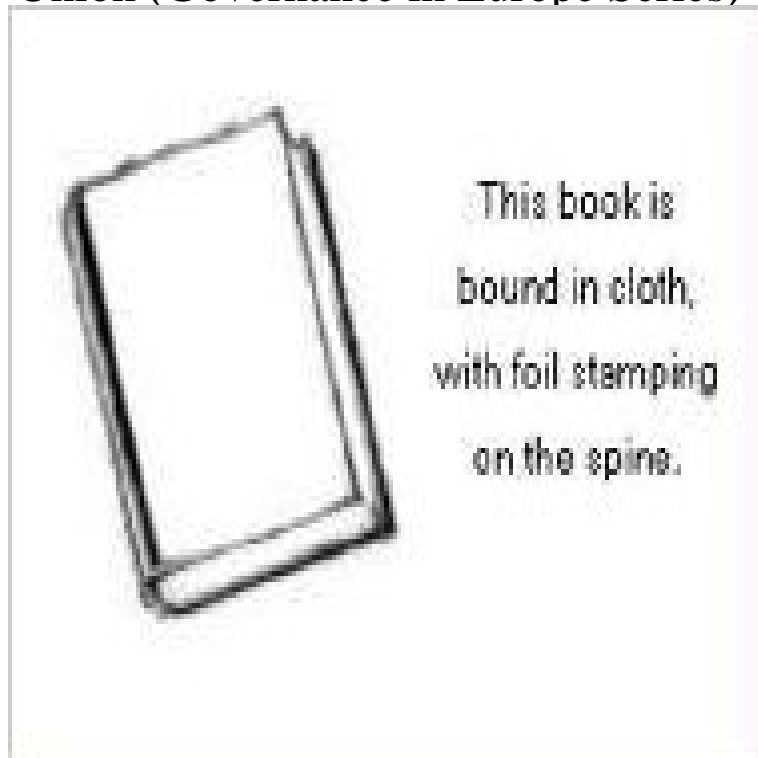


The Euro: European Integration Theory and Economic and Monetary Union (Governance in Europe Series)
