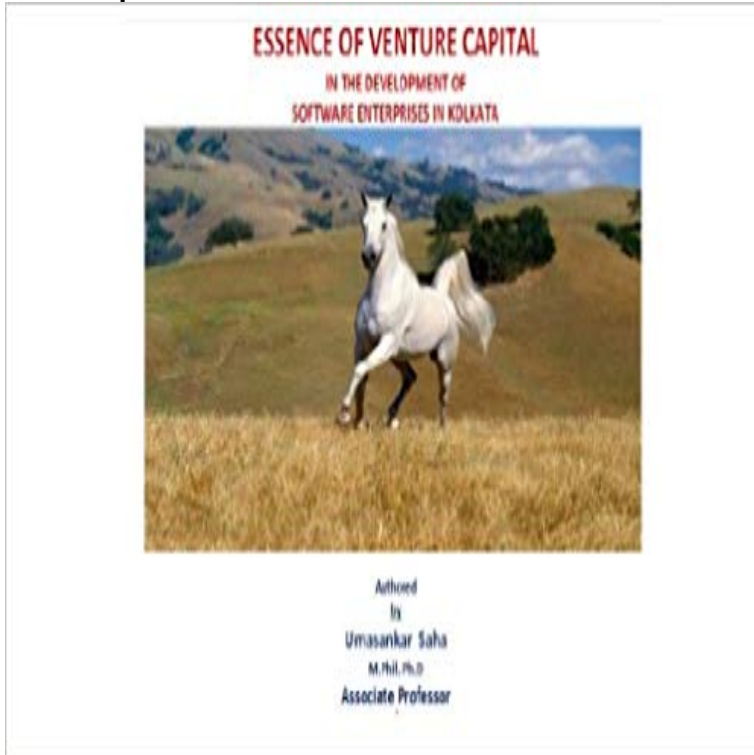


ESSENCE OF VENTURE CAPITAL in the Development of Software Enterprises in Kolkata
